

## CONSENT AND INDEMNITY FORM

I/We, the undersigned, agree to be bound by the rules of Bright Future Nursery School & Crèche.

I/We agree to pay a NON REFUNDABLE registration fee of R350.00 per child within 2 days before starting at Bright Future. School fees are not refundable.

I/We agree to pay the school fees as set out in the fees schedule and agree that a full month is payable for the December/January holiday period, even though the nursery school will close for the holiday season.

I/We understand that a CALENDER MONTH'S NOTICE IN WRITING must be given on my/our Child/children leaving the nursery school and FAILING TO GIVE NOTICE, AGREE TO PAY A FULL MONTH'S FEES in lieu thereof. November and December cannot be given as a notice period if your child is leaving.

I/We give consent to the principal and teachers of the **Bright Future nursery** school and **Crèche** to administer such non-prescription medication as may be necessary to alleviate pain, nausea, vomiting, upset stomach and distress. I/We also permit them to administer prescribed medication, such as antibiotics and allergy medication that I/We shall ask them to do during school hours. Parents will be notified if nonprescription meds need to be given

I/We agree that in the event of the **Bright Future nursery** school and **Crèche** not being able to contact me/us, that I/We empower the principal or teacher, at any given time in emergencies, to take whatever reasonable steps the person feels necessary, in the event of injury or illness of the child/children.

I/We understand that the **Bright Future nursery school and Crèche** and any of its employees will not be held responsible for the payment of any costs, medical or otherwise, should the need arise for my/our child/children to require any medical or hospital attention.

I/We understand that, while the utmost precautions for safety and welfare of my/our child/children will be given, both the **Bright Future nursery school and Crèche** and any of its employees will not be held responsible for and damages which I/We or my/our child/children might sustain, while my/our child/children attend the nursery school.

I/We hereby indemnify **Bright Future Nursery School & Crèche** against any claim, which may be made against it any time, by or on behalf of the child/children in attendance, or in any way related to any activity associated with attendance at **Bright Future Nursery School & Crèche**.
